**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article-309 of the Constitution of India, the Governor of Tripura is pleased to make the following Rules regulating the method of recruitment to the post of **Pharmacist (Allopathy)** under the Animal Resources Development Department, namely :-

**1. Short Title and Commencement :-**

- (a) These rules may be called "Recruitment Rules for the post of **Pharmacist (Allopathy)** under Animal Resources Development Department,
- (b) They shall come into force with effect from the date of their publication in the Official Gazette.

**2. The name of the post shall be specified in column-1 of the Schedule annexed hereto :-**

**3. Number, classification and scale of pay :-**

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Columns-2, 3 & 4 of the schedule annexed hereto :-

**4. Method of recruitment, Age limit, Qualification, etc. :-**

Method of recruitment to the said post, age limit, qualification and other matter relating to the said post shall be specified in columns 5 to 13 of the said schedule.

**5. Disqualification :- No person**

- (a) Who has entered into or contracted a marriage with a person having spouses living  
or
- (b) Who, having a spouse living has entered into or contracted a marriage any person shall be eligible for appoint to the said post.  
Provided that the State Government may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules

**6. Power to relax :-**

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, may relax any of the provisions of these rules with respect to any class or category of persons.

**7. Savings :-**

Nothing in these rules shall effect reservations and other concessions required to be provided for special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.
