**NOTIFICATION**

In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Recruitment Rules for the post mentioned herein the Governor, hereby makes the following rules regulating the method of recruitment to the post of Watch & Ward under the Science, Technology & Environment Department, Government of Tripura.

**1. Short title & commencement:**

- (i) This rules, framed in Schedule annexed herewith, may be called **Recruitment Rules for the post of Watch & Ward** under the Department of Science, Technology & Environment, Government of Tripura.
- (ii) This rules shall come into force on the date of its publication in the Official Gazette.

2. The name of the said post shall be specified in column - I of the schedule annexed here to.

**3. Number, Classification and Scale of Pay.**

The number of the said post, its classification and the scale of pay attached here to shall be as specified in columns-2 to 4 of the Schedule annexed.

**4. Method of recruitment, age limit, qualification etc.**

The method of recruitment to the post, age limit, qualification and other matters relating to the said post shall be specified in Columns 5 to 13 of the said Schedule.

**5. Disqualification: No person**

- (i) Who has entered into or contracted a marriage with a person having spouse living, or
- (ii) Who, having a spouse living has entered into or contracted marriage with any person shall be eligible for appointment to the said post.


Provided that the State Government may, if satisfied that marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

**6. Power to relax**

Where the State Government is of the opinion that it is necessary or expedient to do so, it may by order for reasons to be recorded in the writing to relax any of the provisions of these rules with respect to any class or category of persons.

**7. Savings**

Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled castes, the Scheduled Tribes, Ex- Servicemen and other special categories of persons in accordance with the orders issued by the state Government from time to time in this regard.
