NOTICE INVITING TENDER / QUOTATION

The Quotationer in whose favour the Work Order will be issued will have to complete the supply within the period as mentioned at Sl.No.1 above and in case of failure in completing the supply exercise within the stipulated period without assigning acceptable genuine hindrances, the undersigned reserves the right to rescind the tender as well as the work order in whose favour it has been issued and get the balance work done through other Quotationers at the cost and risk of accepted Quotationer in respect of any increase in the rate and cost of material, etc. and otherwise, if any.
8. No charge for supply of the articles from the Supplier's end to this Registry will be borne by this Registry.
9. Specifications may be obtained from the Court Officer of this Registry during office hours (from 11 AM to 4 PM) on any working days of this Registry. It may please be noted in this connection that the Umbrellas (Gents & Ladies) supplied shall not be acceptable if the Umbrellas (Gents & Ladies) are not tallied with the approved sample.
