Dated, Agartala, the 27th November, 2013

Hon'ble the Chief Justice has been pleased to issue the following direction in respect of transfer of cases from one Court to another under the jurisdiction of the High Court:

"Until and unless cases transferred out are shown to have been received by the transferee Court, the transferor Court shall not show the said cases as 'Disposed of on transfer'. The date of receipt of such cases on transfer by the transferee Court shall, for the purpose of statement, be taken to be the date of 'Institution/receipt on transfer' of those cases in the transferee Court irrespective of entries of such cases made therefor or not."
