TRIPURA BILL NO.2 OF 2019.

THE TRIPURA APPROPRIATION BILL, 2019 (THE TRIPURA BILL NO.2 OF 2019)

A BILL

to provide for the withdrawal of certain sum from and out of the Consolidated Fund of the State of Tripura for the Services of the financial year 2019-20.

BE it enacted by the Legislative Assembly of Tripura in the seventieth year of the Republic of India as follows: -

Short Title

- 1. This act may be called the Tripura Appropriation Act, 2019.
- Issue of a sum of Rs.17746,46,48,000/out of the Consolidated Fund of the State of Tripura for the Financial Year 2019-20.
- 2. From and out of the Consolidated Fund of the State of Tripura, there may be paid sums not exceeding those specified in column-3 of the Schedule amounting in the aggregate to the sums of Rupees seventeen thousand seven hundred forty six crore forty six lakh and forty eight thousand only towards defraying the several charges which will come in course of payment during the financial year 2019-20 (hereinafter referred to as the said year) in respect of the services and purposes specified in column-2 of the said Schedule.

Appropriation

3. The sums authorized to be paid and applied from and out of the Consolidated Fund of the State of Tripura by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation of the said year.

TECHNICAL REPORT

This is Money Bill within the meaning of Article 199 of the Constitution of India.

The Bill attracts the provisions of Article 207 of the Constitution of India. Therefore, recommendation of the Governor is necessary for both introduction and consideration of the Bill in the Tripura Legislative Assembly.

The State Legislature has exclusive power to enact a law on the subject.

STATEMENT OF OBJECTS AND REASONS

This Bill is introduced under Article 204 of the Constitution of India to provide for the appropriation out of the consolidated fund of the State of Tripura of the moneys required to meet the expenditure of the Government of Tripura for the period from the 1st April, 2019 to the 31st March, 2020 for the financial year 2019-20.
