NOTIFICATION

Subject: Guidelines of scholarship CM-SATH (Chief Minister's Scholarship for Achievers Towards Higher Learning)

The School Education Department, Government of Tripura, is introducing the CM-SATH (Chief Minister's Scholarship for Achievers Towards Higher Learning), a new initiative aimed at providing financial assistance to outstanding students of Govt. and Govt.-aided schools of Tripura.

Objective: The primary objective of this scholarship program is to empower meritorious students by alleviating financial constraints for facilitating their higher education journey.

Facilities: Scholarship of Rs. 5000/- per month for students of 2 (two) categories:

- i) For 2 years to 100 10th Board Final Exam pass out students.
 ii) For 3 years to 100 HS Board Final Exam pass out students.

Eligibility: Eligible students for the scholarship must be

- i) A permanent resident of Tripura
- ii) Pass out Board Final Exam from any Govt. or Govt.-aided Schools of Tripura

Selection Procedure: 200 (100 from each category i. e. 10th Board & HS) students will be selected as per merit rank in Board Final Examination. For each category 76 nos. students will be selected from Blocks, 06 nos. from Nagar Panchayats, 13 nos. from Municipal Councils & 05 nos. from AMC based on population (Annexure- A). In case of equal marks achievers, girl students will be prioritized firstly & the younger student as per Date of Birth will be prioritized secondly. The Directorate of Secondary Education (DSE) will collect the names of 200 beneficiaries through District Education Officers. All the beneficiaries have to submit their following supportive documents to DSE through DEOs:

- a) Duly attested Photocopies of
 - i) PRTC
 - ii) 10th Board Admit Card
 - iii) Marksheet of Board Final Exam(10th or HS as per category).

 - v) Self Bank account (linked with Adhaar) details of Passbook
- b) Mobile No.

Financial Involvement: The estimated expenditure for the Scheme in launching year i. e. in 2023-24 F/Y is Rs. 120.00 Lakh for 200 beneficiaries. In 2024-25 F/Y the expenditure will be Rs.240.00 Lakh for 400 beneficiaries and from 2025-26 F/Y onwards the expenditure will be 300.00 Lakh for 500 beneficiaries.

Payment Process: Payment will be done by DSE through DBT System to the beneficiaries.

Monitoring Process: To ensure effective implementation, designated officers from DSE will supervise the entire process.
