Unless all the columns are duly filled in conformity with the aforesaid Order Nos. 43 & 44, the related case/vakalatnama shall be treated as a 'defective' one and placed before the Lawazima Court, till rectification is made by the concerned Advocate(s) by way of furnishing all the required particulars in respect of the parties to that lis.
