## ORDER NO. 90

Dated, Agartala, the 5<sup>th</sup> December, 2015

Hon'ble the Chief Justice has been pleased to modify Order No.85 dated 27.08.2015 to a limited extent.

Filing of memo of appearance/hazira by or on behalf of the accused persons shall not be compulsory. However, in case the lawyers and litigants want to file the hazira, the concerned court may accept the same. It is, however, made clear that there will be no compulsion to file hazira.

As far as witnesses are concerned, the previous order will remain in force and no hazira for presence of witnesses shall be entertained by the courts.

This order will come into force with immediate effect.
