## Order No. 85

Dated, Agartala, the 27<sup>th</sup> August, 2015

Hon'ble the Chief Justice has been pleased to order that in all Criminal Courts, the practice of filing memo of appearance/hajira either by accused person(s) or by witnesses(s) shall henceforth be discontinued. The presence or absence of the accused person(s) or the witness(s) on the relevant date(s) in any particular case shall specifically be recorded in the order sheet by the concerned Criminal Court with mentioning of the respective name(s) of the accused person(s) or the witness(s).

This order will come into force with immediate effect.
